SECTION 4: First-aid measures

4.1. Description of first aid measures

First-aid measures general : Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital.

First-aid measures after inhalation : Remove the victim into fresh air. Respiratory problems: consult a doctor/medical service.

First-aid measures after skin contact : Wash immediately with lots of water. Soap may be used. Take victim to a doctor if irritation persists.

First-aid measures after eye contact : Rinse immediately with plenty of water. Remove contact lenses, if present and easy to do. Continue rinsing. Do not apply neutralizing agents. Take victim to an ophthalmologist if irritation persists.

First-aid measures after ingestion : Rinse mouth with water. Do not induce vomiting. Call Poison Information Centre (www.big.be/antigif.htm). Consult a doctor/medical service if you feel unwell. Ingestion of large quantities: immediately to hospital.

4.2. Most important symptoms and effects (acute and delayed)

Potential Adverse human health effects and symptoms : Causes skin irritation. May cause respiratory irritation. Causes serious eye irritation.

Symptoms/effects after inhalation : AFTER INHALATION OF DUST/MIST: Irritation of the respiratory tract. Irritation of the nasal mucous membranes.

5.3. Special protective equipment and precautions for fire-fighters

Precautionary measures fire : Exposure to fire/heat: keep upwind. Exposure to fire/heat: consider evacuation. Exposure to fire/heat: have neighbourhood close doors and windows.

Firefighting instructions : Dilute toxic gases with water spray. Take account of toxic/corrosive precipitation water.

7.1. Precautions for safe handling

Remove contaminated clothing immediately. Clean contaminated clothing. Keep container tightly closed. Powdered form: no compressed air for pumping over.

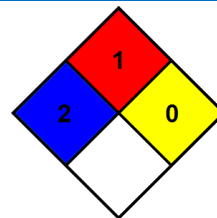
