## SECTION 4: First-aid measures

### 4.1. Description of first aid measures

First-aid measures general	: Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. First-aid measures after ingestion	: Rinse mouth with water. Ingestion of large quantities: immediately to hospital. Call Poison Information Centre ( <a href="http://www.big.be/antigif.htm">www.big.be/antigif.htm</a> ).
