SECTION 4: First-aid measures

4.1. Description of first aid measures

- First-aid measures general : Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital.
- First-aid measures after inhalation : Remove the victim into fresh air.
- First-aid measures after skin contact : Wash immediately with lots of water (15 minutes)/shower.
- First-aid measures after eye contact : Rinse immediately with plenty of water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Take victim to an ophthalmologist. Do not apply neutralizing agents.
- First-aid measures after ingestion : Rinse mouth with water. Immediately after ingestion: give lots of water to drink. Ingestion of large quantities: immediately to hospital. Call Poison Information Centre (www.big.be/antigif.htm).

4.2. Most important symptoms and effects (acute and delayed)

- Potential Adverse human health effects and symptoms : Practically non-toxic if swallowed (LD50 oral 2000/5000 mg/kg). Slightly irritant to skin. Slightly irritant to eyes.
- Symptoms/effects after ingestion : Nausea. Vomiting.
- Chronic symptoms : ON CONTINUOUS/REPEATED EXPOSURE/CONTACT: Skin rash/inflammation.

- Firefighting instructions : Dilute toxic gases with water spray. Take account of toxic fire-fighting water. Use water moderately and if possible collect or contain it.
- Protection during firefighting : Heat/fire exposure: compressed air/oxygen apparatus.

6.1. Personal precautions, protective equipment and emergency procedures

6.1.1. For non-emergency personnel

- Protective equipment : Gloves. Protective clothing. Dust cloud production: compressed air/oxygen apparatus.
- Emergency procedures : Mark the danger area. Prevent dust cloud formation, e.g. by wetting. No naked flames. Wash contaminated clothes.
- Measures in case of dust release : In case of dust production: keep upwind. Dust production: have neighbourhood close doors and windows. In case of dust production: stop engines and no smoking. In case of dust production: no naked flames or sparks. Dust: spark-/explosionproof appliances/lighting equipment.

6.2. Environmental precautions

Prevent soil and water pollution. Prevent spreading in sewers.

6.3. Methods and material for containment and cleaning up

Methods for cleaning up : Stop dust cloud by humidifying. Scoop solid spill into closing containers. Powdered: do not use compressed air for pumping over spills. Carefully collect the spill/leftovers. Take collected spill to manufacturer/competent authority. Clean contaminated surfaces with an excess of water. Wash clothing and equipment after handling.

Other information : Dispose of materials or solid residues at an authorized site.

7.1. Precautions for safe handling

Precautions for safe handling : Avoid raising dust. Keep away from naked flames/heat. In finely divided state: use spark-/explosionproof appliances. Finely divided: keep away from ignition sources/sparks. Carry operations in the open/under local exhaust/ventilation or with respiratory protection. Comply with the legal requirements. Clean contaminated clothing. Thoroughly clean/dry the installation before use. Do not discharge the waste into the drain. Powdered form: no compressed air for pumping over. Keep container tightly closed.

Hygiene measures : Do not eat, drink or smoke when using this product. Always wash hands after handling the product. Separate working clothes from town clothes. Launder separately.
